WHEREAS, the City Council has received applications from citizens desiring to serve on Sustainability Commission, and subsequently interviewed applicants for service on this Commission.


NOW, THEREFORE, BE IT RESOLVED BY THE CITY OF FOREST GROVE AS FOLLOWS:

- ***Joseph Baxter, Public Safety Advisory Commission, Rural Fire District, Term Expiring December 31, 2020***
- ***Raymond Arkus, Public Safety Advisory Commission, At-Large, Term Expiring December 31, 2021***
- ***Kenneth Cobleigh, Sustainability Commission, Agricultural, At-Large, Term Expiring December 31, 2019 (currently appointed to Parks and Recreation Commission).***
- *Tom Cook, Planning Commission, was not selected for appointment, and he has been notified (currently appointed to Committee for Community Involvement).*
- *Richard Kidd, Budget Committee, Economic Development Commission and Planning Commission*

After Council deliberation, Council collectively made recommendation to appoint the above-noted applicant as shown in **bold** and asked staff to draft a not appointed letter for the applicant not recommended for appointment.
