WHEREAS, the City of Forest Grove is currently a participant in the Washington County Cooperative Library Services (WCCLS) information network; and

WHEREAS, the Washington County Cooperative Library Services (WCCLS) Executive Board has been the representative for member libraries; and

WHEREAS, current WCCLS Information Network Agreement expires on June 30, 2021; and

WHEREAS, consensus has been reached by the Executive Board on an amendment to extend the current agreement until June 30, 2022; and

WHEREAS, the governing bodies of the participants need to approve the Amendment attached as Exhibit A.


NOW, THEREFORE, BE IT RESOLVED BY THE CITY OF FOREST GROVE AS FOLLOWS:
