

RESOLUTION NO. 2020-109

**RESOLUTION MAKING APPOINTMENTS TO
CITY OF FOREST GROVE ADVISORY BOARDS,
COMMITTEES AND COMMISSIONS**

WHEREAS, Council Rules of Procedure §14 states the policy relating to Advisory Boards, Committees, and Commissions (B/C); and

WHEREAS, pursuant to §14.3, to be eligible for appointment, a person must be 18 years of age or older and a Forest Grove resident for the duration of the appointed term unless expressly provided for by the adopted bylaws for the Board or Commission and Student appointees must be high school grade level and residing or attending school, including home-schooled, in Forest Grove; and

WHEREAS, pursuant to §14.6, unless required by state law, all members shall be voting members and shall serve four (4) year terms. Student members shall be voting members and shall serve two (2) year terms. Terms shall be staggered beginning January 1 and ending December 31; and


WHEREAS, pursuant to §14.10, Council interviewed applicants in work sessions held on September 28, October 12, October 26, November 9 and November 23, 2020, and arrived at a general consensus to make the B/C appointments and reappointments.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY OF FOREST GROVE AS FOLLOWS:

Section 1. The City Council is hereby approving the B/C applicant appointments and reappointments as outlined in Exhibit A.

Section 2. This resolution is effective immediately upon its enactment by the City Council.
