## To Qualify

- You must be a resident of the City of Forest Grove.
- Provide only ONE of the following options along with a Government Issued Photo ID:
  - Award letter for TANF (Temporary Assistance for Needy Families)
  - Award letter for SNAP (Supplemental Nutrition Assistance Program)

## Approval Process

- Please allow up to two weeks for processing and approval. Applicants will be notified by phone or email.
- One award per person, per period, categorized as:
  - Period 1 (July 1- December 31); credit expires December 31
  - Period 2 (January 1 - June 30); credit expires June 30
- Each award is only valid during the associated period. A new application needs to be submitted with each new period.
- You may apply for financial assistance at any time during a period. You may only apply once per period.
- Submit this form along with the required documents by email to [mwilliams@forestgrove-or.gov](mailto:mwilliams@forestgrove-or.gov) , or in person at the Forest Grove Aquatic Center (2300 Sunset Drive, Forest Grove).

## Award Details

- Qualifying recipients will be awarded \$100 per person, per period.
- Awarded funds will not be rolled over or extended beyond the period for which it was approved. Any unused awarded funds will expire at the conclusion of the period.
- Awarded funds may be applied to classes and programs occurring outside of the period for which the award was granted.
- Awarded funds may be applied to City of Forest Grove Parks & Recreation classes, programs, and memberships only.
- Awarded funds CANNOT be applied to facility rentals.
- Before funds are awarded, you must create a CIVIC REC account at <https://secure.rec1.com/OR/forest-grove-or-parks-recreation/catalog>. For assistance, call (503) 992-3238 or visit the Forest Grove Aquatic Center (2300 Sunset Drive, Forest Grove).
- Awarded funds are credited directly onto your CIVIC REC account.

## How to Register After Receiving Funds

To sign up for classes and programs, go to <https://secure.rec1.com/OR/forest-grove-or-parks-recreation/catalog> OR contact us at (503) 992-3238. Awarded funds appear as Credits on your CIVIC REC account and can be applied to approved programs, classes and memberships.

## Additional Notes:

- The approval of financial assistance is subject to the availability of funds within the Parks & Recreation budget. While we make every effort to assist as many individuals as possible, financial assistance is not guaranteed and is contingent upon the current availability of funds. Existing funds have been generously provided by community donations.
- The Fun For All Fund is available to all ages and abilities.
- All classes and programs are first come first serve. Financial assistance award does not guarantee access to a class or program.
- Unused funds are not eligible for cash refund.
- Applicant information, government issued ID, and TANF or SNAP award letter recipient information must all match.
- Repeated no-show offenses or misuse of award may result in loss of award or future access to this program.
